Dear Healthcare Professional,

Availability of LYCLEAR SCABIES CREAM (AUST R 46343) - alternative supply arrangement under Section 19A of the Therapeutic Goods Act.

Due to shortage of the Australian registered LYCLEAR SCABIES CREAM (AUST R 46343), Reach Pharmaceuticals has arranged the supply of an alternative product called **PERMETHRIN - permethrin cream 5% w/w cream (Encube)** registered and marketed in the USA.

PERMETHRIN - permethrin cream 5% w/w cream (Encube) is not registered in Australia and supply is authorised under an exemption granted by the Therapeutic Goods Administration (TGA) under Section 19A of the *Therapeutic Goods Act*, 1989 until 31st October 2024 for the following indications:

For the treatment of infestation with sarcoptes scabiei (scabies).

The dosage instructions and directions for use approved in Australia should be used when applying the alternative USA product. These instructions are:

Directions for use:

Adults and children 2 years and over: Apply cream to the whole body except the head and face. The cream should be left on for at least 8 hours, then washed off with soap and water.

Dosage:

Adults and children over 12 years: Up to 30 g

Children: 5 to 12 years: Up to 15 g

1 to 5 years: Up to 7.5 g

6 months to 1 year: Up to 3.75 g

A few adults may need to use more than 30 g, but do not apply more than 60 g.

The S19A approved USA product is identical in active ingredient and strength to the Australian registered product. A comparison table of differences between excipients is given in the table below:
